## Short Form Material Transfer Agreement

(4) pPNL9 = secretion vector used for final production of scFv  
(5) YVH10 = yeast strain used for secretion of scFv  
(6) scFv Control in EBY100 = positive control for scFv expression and antigen binding  
(7) Control biotinylated Antigen

In response to the RECIPIENT's request for the MATERIAL, the RECIPIENT shall agree to the following before the RECIPIENT receives the MATERIAL:

- 1) The MATERIAL is the property of the PROVIDER and is made available **as a bailment** for the conduct of research activities.
- 2) The MATERIAL SHALL NOT BE USED IN HUMAN SUBJECTS.
- 3) The MATERIAL will only be used for research projects or teaching funded solely by the U.S. Government.

- 4) The MATERIAL will not be distributed to anyone other than the RECIPIENT Scientist without the PROVIDER's written consent. The RECIPIENT shall refer any request for the MATERIAL to the PROVIDER. To the extent supplies are available, the PROVIDER agrees to make the MATERIAL available, under a separate Simple Letter Agreement, to other scientists for teaching or U.S. government funded not-for-profit research purposes only.
- 5) The export or deemed export of goods and/or technical data may require some form of export control license or other authority from the United States Government and failure to obtain such export control license may result in criminal liability under the United States laws. The RECIPIENT shall first obtain the written consent of BATTELLE prior to submitting any request for authority to export any such technical data.
- 6) The RECIPIENT agrees to acknowledge the source of the MATERIAL in any publications reporting its use.
- 7) Any MATERIAL delivered pursuant to this Agreement is understood to be experimental in nature and may have hazardous properties. THE PROVIDER MAKES NO REPRESENTATIONS AND EXTENDS NO WARRANTIES OF ANY KIND, EITHER EXPRESSED OR IMPLIED. THERE ARE NO EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR THAT THE USE OF THE MATERIAL WILL NOT INFRINGE ANY PATENT, COPYRIGHT, TRADEMARK, OR OTHER PROPRIETARY RIGHTS. Neither the U.S. Government nor PROVIDER nor any affiliated company of PROVIDER shall have any liability whatsoever to RECIPIENT or any other person for or on account of any injury, loss, or damage, of any kind or nature sustained by, or any damage assessed or asserted against, or any other liability incurred by or imposed upon RECIPIENT or any other person, arising out of or in connection with or resulting from the use, storage, or disposal of any MATERIAL provided by PROVIDER. RECIPIENT shall hold the U.S. Government, PROVIDER, and any affiliated company of PROVIDER, harmless in the event the U.S. Government, PROVIDER, or any affiliated company of PROVIDER, is held liable. Further, RECIPIENT agrees to assume the defense of any suit brought against PROVIDER or any affiliated company of PROVIDER resulting from any action of RECIPIENT undertaken under this Agreement.
